To have City Council discussions and decisions on unnoticed items would prevent the type of public input necessary to make governmental decisions.

3. JOINT WORK SESSION OF THE SCHOOL BOARD AND CITY COUNCIL - ITEMS FOR DISCUSSION

- 3.1. Amendments to the Joint Powers Agreement

- 3.3. Dissolution of Successor Agency and Oversight Board
The City Council will provide an update on the schedule to transfer duties of the Successor Agency and the Successor Agency Oversight Board to Tulare County.
- 3.4. Randle Avenue CDBG Grant Application
The City Council will share information regarding a potential joint grant application for developing Randle Avenue improvements and extending utilities, which would relieve Dinuba Unified School District of the responsibility of doing so during future development of the property.
- 3.5. Kern and College Street Closure – Every 15 Minutes
The School District Administration would like to extend its gratitude to the City for the closure of Kern and College Avenues, during the Every 15 Minutes activity at Dinuba High School.
- 3.6. Dinuba High School - Student Housing
The Board and City Council will discuss options for student housing at Dinuba High School including remodeling of the campus or relocating the campus. David Iwanaga, District Architect, will present additional information regarding housing options.
