- Exhibit spaces are 10 x 10, if additional space is needed you may request it on the application.
- Exhibit spaces are assigned at the event coordinators discretion.
- All exhibitors selling items must collect and pay California tax on all sold items.
- Exhibitors must have their booth manned for the duration of the event.
- **Event location:** Nebraska Park @ 1000. Nebraska Ave Dinuba, CA 93618
- **Event time:** 11:00am -1:00pm
- **Setup time:** Begins at 9:30am and you must be ready by 10:30am.
- Prior approval is needed for vehicles to drive on the grass, each exhibitor will need to be prepared to handcart their items with dollies.
- **Tear down:** starts at 1:00pm.
- Must be cleared out by 2:00 pm.
- Event coordinator, City staff, volunteers and their partners will not be responsible for any lost or stolen items from exhibit.
- Event management has the right to close the event early in the event of inclement weather.
- Exhibitors are NOT permitted to leave early unless approved.
- Electricity will NOT be provided.
- Event management has the right to remove materials that are not acceptable.
